DIRECTIONS	

- 1. The Tribunal having received a Notice of Appeal on 02 August 2021, Tribunal Judge Worth issued directions on 11 August 2021 that the Appellant state, by no later than 02 September 2021, which provision of Schedule 6 of the Charities Act 2011 permitted the Appellant the right to appeal to this Tribunal.
- 2. The Appellant has made an application for an extension of time to comply with the directions issued on 11 August 2021. I note that the Appellant has enclosed Form N244 (which I do not consider necessary to this Tribunal); and in that form and the application for an extension it states:

'The ground is that the claimant Paola Pirrello contested the court's jurisdiction between the First Tier Tribunal General Regulatory Chamber (Charity) and The High Court of Justice'.

- 3. I note the objections raised by the Charity Commission to the granting of a further extension, the Appellant having been granted 3 weeks by Judge Worth on 11 August 2021.
- 4. I have considered the directions issued by Judge Worth and note that in response the Appellant now appears to contest the jurisdiction of this Tribunal which was not stated before the Judge. In the circumstance I consider it fair and just to permit an extension to the Appellant. Rule 2, The Tribunal Procedure (First-tier Tribunal) (General Regulatory Chamber) Rules 2009.

IT IS NOW DIRECTED AS FOLLOWS:

- 5. The Appellant is permitted an extension to **01 October 2021**. Rule 5(3)(a) applied.
- 6. By no later than **01 October 2021**, the Appellant is to clearly state the following:
 - 6.1. What provision under the of Schedule 6 of the Charities Act 2011 permits the Appellant to appeal to this Tribunal referring to-
 - 6.1.1. Column 1 which "decision, direction or order" has been made by the Charity Commission; AND
 - 6.1.2. How they are the (or a) permitted "Appellant / Applicant" in column 2; **OR**
 - 6.2. The ground(s) upon which the Appellant contests the jurisdiction of this Tribunal and why the Appellant considers the High Court to be the appropriate venue; and
 - 6.3. What provision(s) the Appellant considers deems the High Court as the appropriate venue for this matter.
- 7. The Appellant is to refer to the directions issued by Judge Worth on 11 August 2021 and is hereby notified that a failure to comply with directions issued by the Tribunal may result in the striking out of this appeal pursuant to Rule 8(3)(a).
- 8. In the event that these directions are not complied with this matter will be placed before a Judge of the Tribunal <u>after</u> the 01 October 2021 for consideration of striking out the appeal.
