And upon the parties being unable to agree directions

**IT IS DIRECTED as follows:**

**Mode of hearing**

1. This appeal shall be determined on papers **on the first available date after 2 June 2017.**

**Bundle of documents**

2. A hearing bundle is to be prepared by the Respondent and sent to the Appellant **by 5pm on 19 April 2017.** The contents of the hearing bundle are to be determined by the Respondent alone, having regard to the issues in the appeal and the overriding objective. It must include the Appellant's Notice of Appeal, Reply and any other relevant documents previously relied on by the Appellant in its communications with the Respondent and Tribunal.

### **Witness statements**

3. **By 5pm on 3 May 2017** the Respondent is to serve on the Appellant any written witness statements on which it wishes to rely.
4. **By 5pm on 8 May 2017**, the Appellant may serve on the Respondent any witness statement(s) replying to points raised in the Respondent's written witness statement(s).

### **Written submissions**

5. **By 5pm on 10 May 2017** the Respondent is to file its written submissions with the Tribunal and serve them on the Appellant.
6. **By 5pm on 22 May 2017**, the Appellant may serve on the Respondent and file with the Tribunal a written submission, limited to replying to the points raised in the Respondent's written submission.

### **Bundle of authorities and statutory materials**

7. The Respondent is to serve a bundle of authorities and statutory materials on the Appellant at the same time as its written submissions referred to at paragraph 5 above. This shall contain only those authorities referred to in its written submissions.

### **Lodging of bundles with the Tribunal**

8. A final version of the consolidated hearing bundle (to include the witness statements and written submissions) is to be prepared by the Respondent and four hard copies are to be lodged with the Tribunal **by [7 days BEFORE THE HEARING DATE]**.
9. A final version of the authorities bundle is to be prepared by the Respondent and 4 hard copies are to be filed with the Tribunal **by 5pm on [7 days BEFORE THE HEARING DATE]**.

### **Other**

10. Each party has permission to apply to vary these directions or to apply for further directions. Any such application is to be in writing, to set out the full reasons for the application and (where applicable) to be filed before the time limit for complying with the direction has been reached.
11. Unless specified under The Tribunal Procedure (First-Tier Tribunal) (General Regulatory Chamber) Rules 2009, all written correspondence sent to the Tribunal must be copied to all other parties or sent to the other parties as soon as reasonably practicable.
